Resource Specialist – Pfarr 1) Helped organized and attended Cultural Resources Training so district staff can be certified. 2) Took MPCA on a tour of the Plum Creek Sub-Watershed to try to get 319 funds into watershed. 3) Have 14 projects ready for construction of which 11 are funded through EQIP. We are still trying to locate funds to provide cost share for approximately 56 additional projects. 4) 3 CREP wetland restorations are designed and ready to install. 5) Had a good meeting with several DNR staff to work on an engineering design for stream bank stabilizations. 6) Working on Soil Health Coalition for MN. 7) Helped out with 5th grade Ag day. 8) Mike Landuyt was selected as Regional Cattleman of the year. Did an interview with a film crew on Landuyt's farm. 9) Will be attending the Soil Health Academy July 31-August 2, 2018.

County Commissioner – Salfer 1) Design is being worked on for Dam removal on the Cottonwood River in Lamberton and Sanborn.

CANDIDATE PROSPECTUS: Copies of candidate prospectus were handed out to each supervisor. The document answers many of the questions supervisors may have about serving as president or vice president for MASWCD.

COMPUTER UPDATE: There are currently three districts using our server. To make things simpler it was decided to have an annual user fee of \$825.00 a year, plus others licenses and registrations for some of the programs rather than per issue charge.

NRCS RE-ORGANIZATION: Handed out copies of the proposed NRCS re-organization plan.

LEGISLATIVE UPDATE: Handed out copies of the 2018 MASWCD legislative session summary.

AREA V MEETING: Area V Meeting will be held at the "The Rock", in Granite Falls on Thursday, June 21, 2018.

DNR WELL CONTRACT: District entered into an agreement with DNR to continue monitoring six wells across the county.

FARMBILL GRANT: A grant request was submitted to continue the funding for a .75 farm bill position for FY 2019.

LOCALLY LED WORKHOP: There will be six Workshops across Minnesota to gather input to strengthen the conservation partnership between, local, state and federal entities. There will be one in Marshall on August 2, 2018. It is recommend for supervisors, staff as well as NRCS attend.

WATERSHED CONSERVATION PLANNER INITIATIVE: BWSR and NRCS have entered into a three-year agreement to accelerate conservation planning in seven watersheds in Minnesota. The Middle Minnesota Watershed has been selected as one of the seven. They have funds to hire full time planners and it has been suggested that Redwood SWCD act as host. Motion by Timm, second by Tauer to authorize Redwood District to act as host. Motion carried.
