District Administrator – Bernhardson 1) NRCS is requesting proposals for Conservation Collaboration grants to help deliver their programs. Redwood SWCD will be meeting with Renville SWCD to collaborate on a possible application.

RCRCA: - No meeting in March

*MASWCD Legislative Briefing*: Potter and Timm reported on legislative meetings where we met with five legislators.

County Commissioner – Discussion is still ongoing regarding Courthouse.

*NRCS DC* – No report available.

**CRP SIGNING:** Several years ago, we were asked to designate a district staff person to sign CRP plans. At that time, the board appointed the district administrator. District Administrator is recommending that it be changed to Resource Specialist. Motion by Carter, second by Plaetz to authorize the Resource Specialist to sign all future CRP contracts. Motion carried.

**BUFFER UPDATE**: Copy of Buffer Cost Share Application spreadsheet was provided to supervisors. Spreadsheet was forwarded to BWSR on February 28, 2018. We encumbered a total of \$61,699.20, including \$10,283.20 Technical and Administrative. Unencumbered balance was paid to BWSR on March 1, 2018.

**VEHICLE:** Updated board on Vehicle. Counties insurance does not allow non-county employees to drive their vehicles. There is not a lease program that incorporates the bid assistance that is available. Bids were requested from three businesses as well as the state pool, for a 2018 Traverse. Bids were received from the state pool and two businesses. Motion by Plaetz, second by Timm to purchase vehicle through H & L Motors at their bid price for a 2018 Traverse. Motion carried.

**DEBBAUT WETLAND RESTORAITON PROJECT**: Debbaut's wetland restoration plans were presented to the board. The project will eliminate and re-route Redwood County tile and therefore, there needs to be a petition presented to the ditch authority removing benefits from the system. Motion by Carter, second by Plaetz agreeing Redwood SWCD be one of the petitioners. Motion carried.
