DESIGNATE DEPOSITORY: Motion by Tauer, second by Plaetz to designate Minnwest Bank, M.V. as the safekeeping entity of all deposits, including deposits that exceed FDIC insurance limits and designate Edward Jones as financial broker for investments where a broker's certificate will be requested. Motion carried.

PETTY CASH CUSTODIAN: Motion by Plaetz, second by Tauer to designate the office assistant as custodian of the petty cash funds. Motion carried.

If anyone other than those listed provide these services it will be noted in the minutes who is providing technical assistance. Motion carried.
